Safety Officer: Jim Newton: Well summer approaches and already several areas have seen triple digit temperatures. When warmer weather arrives, so does the possibility of heat injury. Heat cramps, heat exhaustion, and heat stroke are the three forms of heat injury. The first one you're likely to encounter is heat cramps. Symptoms are painful cramps in the stomach, arm and leg muscles. Cramps are caused by not replacing the salt and fluids during outdoor activity. (This often happens during exercise in the heat) Remedy is to stop activity and gently stretch affected muscles, drink cool water or electrolyte solution (low in sugar). The second form of heat injury is heat exhaustion. Symptoms are weakness, fatigue, and fainting. Again the symptoms are brought on by excessive loss of salt and water through perspiration. As heat exhaustion sets in, perspiration decreases and the skin and body temperature rise. Typically core body temperature rises to 104 degrees F. Treatment is to

move to a cool shaded area, remove tight clothing and give the person fluids (if the person is conscious). Apply active cooling measures, such as a fan or ice towels if the body's core temperature is elevated. See a physician to access the needs of fluid/electrolyte replacement and further medical attention, especially if nausea and vomiting are present. The most serious of the heat injuries, is heat stroke. Symptoms are nausea, seizures, and confusion or disorientation. Unconsciousness and coma are possible. Heat stroke may occur with no preceding signs of heat injury. This is a life threatening event! Treatment is CALL 911 immediately for emergency services. Lower core body temperature as quickly as possible. Remove as much clothing as possible. Apply ice packs to the armpits, groin and neck areas. Continue trying to cool the victim until emergency crew arrives. With the lake near our field, I would transport the victim to the lake and immerse them in it, up to their neck, and wait for medical help to arrive.

With that being said, we all hope to never be a victim of heat injury and the best way to do that is through prevention. I don't normally endorse a product but recently saw on TV a cooling towel endorsed by professional athletes called an "Endura-cool" towel. (They also have a bandana made of the same material) I decided to get one and test it. My first test was unimpressive. I wet the towel with cool water and took the temperature of the towel. It was 74 degrees F. Then like the

instructions say, I snapped the towel, and waited about 30 seconds. The temperature had dropped to 68 degrees F. I wasn't impressed. This all took place indoors with the indoor temperature at 78 degrees F. The second test I performed did impress me. I wet the towel (after it had dried) with hot water and took the temperature. The towel was 97 degrees F. I then snapped the towel and waited 30 seconds. The towel was again at 68 degrees. It remained at approximately this temperature for about 40 minutes. The final test was done outside with the temperature 92 degrees. The towel was soaked with the garden hose and the temperature of the towel was 85 degrees. I snapped the towel and it cooled to 67 degrees (there was a slight breeze outside) I put it around my neck and felt cold to the touch. It remained cool for about 20 minutes, I again snapped the towel and it cooled again to 69 degrees and remained cool for another 20 minutes. At that point the towel was drying out. I think you can see the benefit of having a useful item like this on a warm day. I highly recommend having one to make life a lot more bearable in the hot Texas sun. Lowe's home improvement center has them and they sell for around \$15. My wife also saw a different cooling towel at Albertson's for around \$8 but I have not tested that one.


